The following user guide will be a brief introduction and explanation into what our indicator package is doing and why it is so powerful.

Thank you again for your interest in our programs. We highly value your participation in the learning process and know that if you put in the work necessary you can dramatically improve your profit potential with our programs.

Fibonacci Projections and Retracements defined

Fibonacci price projections and retracements are very powerful ratios that can be used as a leading indicator. They use the current underlying structure of the market to attempt to predict where the market may go in the future. Fibonacci ratios are common in almost everything in nature from flowers, to the human body, seashells etc. Our intention is to show you how you can use this powerful tool to assist you in your trading. The basics of market price action are determined by supply and demand. This supply and demand can be measured in waves with charts and graphs. Elliot wave technicians attempt to do by counting waves. VERY GOOD users of Elliot wave have a high probability of calling exhaustive turning points or wave completions. The downside and the challenge to this methodology is that Elliot wave is extremely ambiguous and often too difficult for most traders to implement into their trading strategy. Fibonacci ratios however are just as, if not more powerful and can be done under a more rigid set of rules. After all, rules and discipline are the building blocks for successful trading. Fibonacci ratios are easy to calculate. You take the range from one pivot to the next and do the math. Simple. Many traders now use spreadsheets and simple charts and graphs to do basic fibonacci ratios. Some common ratios are .382, .500, .618 1.00 1.382, 1.618, 2.00 and 2.618. These ratios also as they get larger tend to have more exhaustive qualities. Where this takes a powerful turn is when you assemble a " CONFLUENCE" of these fibonacci ratios in a well-defined area.

When you are able to take that one step further and apply a confluence of ratios from multiple timeframes and multiple degrees within the same chart, that confluence area develops into a powerful synergistic area that can be effectively traded to or off of depending upon your personal trading style. Our T-3 Fibs ProTrader will automatically do this complex, multiple timeframe analysis and automatically plot the areas of highest confluence and also tell you the strength of that level relative to other areas on the charts. The program automatically calculates the best pivots from which to do

projections and retracements from on each of your specified timeframes, runs all possible fibonacci ratios and then plots those projections individually for you to see or will automatically rank them according to their exhaustive qualities and number of each in the confluence areas for you. Even if you had all day to run calculations you it would be very difficult to duplicate the accuracy and performance of the indicators. However, the old adage time=money has never been truer than in trading the markets and T-3 Fibs ProTrader will give the foresight needed and the time necessary to make GOOD trading decisions based upon ALL possible combinations of data.

T-3 Fibs ProTrader How It Works

The purpose of this indicator is to make money by calculating in advance where the market has the highest potential to go, stop and turn around. This knowledge will give you the foresight to make *HIGHLY EDUCATED* trading decisions before you enter the market.

How is this possible? ---- First a very small lesson on fibonacci price confluence analysis.

Fibonacci projections and retracements are, by simple definition: using known ranges or swings in the market that have already happened (high and low pivots) and then multiplying that range by known fibonacci ratios then adding or subtracting that (total range) to or from those pivots. Then using those projections and past ranges in an attempt to predict where the market could go to and stop in the near future by plotting areas where there is a higher number of projections and retracements falling in one area.

Once we have these fibonacci projections we look for a *GROUPING* or *CONFLUENCE* of the projections. Typically there will be 3-6 areas where the majority of your projections and retracements will fall into a relatively tight area. The confluence areas tend to have a high occurrence of support and resistance. These areas become much more powerful and useful as support and resistance areas as additional ratios are added from different areas on the same chart and *ALSO* when this area of confluence is also visible from several different timeframes. For example confluence from a1-minute, 5-minute, 30-minute chart in the same area will be much more powerful then just one of the timeframes by itself.


This predictive analysis is done with 4 types of Fibonacci projections. Even using just one of these projection techniques will give you a distinct advantage over the market but when you combine these four power techniques into one complete analysis along with multiple time frame analysis you get the most powerful, synergistic combination available to you are a trader for pre-determining support and resistance. The T-3 Fibs ProTrader will automatically do all possible combinations of the Fibonacci analysis for you without you having to do any of these calculations or pivot detection yourself.

The 4 main types of Fibonacci Projections Used


There are 4 main types of Fibonacci Price projections that can be done. Definitions and examples of each will be shown.

- 1. Extensions
- 2. Alternates
- 3. Expansions
- 4. Retracements


1. Extensions take the range from point #1 to Point #2 and multiplying that distance by a Fibonacci number, add the two numbers together and project into the future where a possible turning point could be.




2. Alternates take the distance between point #1 and point #2 and adding that distance to point #3 to give you another type of projection into the future.



3. Expansions take the distance from the # 3 pivot to the #2 pivot and then multiply that distance by Fibonacci numbers and add that range to the #3 pivot.



4. Retracements take the distance from one pivot to the next. Preferably a #1 to a #2 pivot and take a portion of that range that is generally 100% or less. Common ratios to calculate retracements are .382, .500, .618, and .786.



INPUTS FOR THE INDICATOR

What do the inputs mean and how can you change them to make the program specific to your needs? First lets cover the inputs and their definitions.

TIMEFRAMES: will synthetically build higher timeframes from the timeframe that is plotted on your chart. You can build from 1-10 higher timeframes from your chart. 10 is the maximum number and is usually all that is needed with the exception of a daily chart.

Sensitivity - The higher the sensitivity the LESS SENSITIVE the indicators are to pivots and the lower the swing strength the MORE SENSITIVE the indicator will be for catching all the moves. Usable ranges are from 2-3 on daily data to 21-35 for indexes all the way up to 125 for the most major areas on data that is volatile and choppy both like a 10 year notes contract.

P_EXT_ALT_EXP_RTC – This input will tell the program which projections and retracements you would like to use to do your analysis for Price - In an effort to make this type of analysis suited to each individual trader and their personal preferences you may specifically turn on and off every possible combination of the indicators themselves. Again the program is pre-set and no adjustments need to be made. You must also tell the program which Fibonacci projections, retracements that you would like to run on each timeframe.

The first digit out of the 3 turns on and off the # plot for the pivots themselves. ("<u>7</u>62,) The auto prep will not plot pivot numbers.

CONFLUENCERANGE – after the program normalizes the data set it will start at the bottom of the range and start a scan. This input controls how WIDE the scan is for confluence. The larger the number the broader the window of confluence. .13 is the best default however up to .5 is the usable range that would be useful. REMEMBER-we are trying to find the HIGHEST probability turning point. A lot of this width will depend on you and your objectives for the market, how large you wish stops to be etc. A range of less than 1 or 1% is generally a very large window. The smaller you make this range down to .08% the "tighter" the confluence window will be and the more demanding the indicator will be on what is CONFLUENCE.

MAXIMUM_FLU_BOXES - This is the number of confluences that the program will look for initially when it is doing it's analysis. The max. is 30 and default at 28 is usually never to be changed.

MAXFLUDISTANCE - this is how far the program is going to look above and below the market when doing it's analysis. In S&P futures if range is 10-15 points then we want to have a setting that is at least twice the normal range. (20-25) points. If we are trading a stock that is only 1 dollar normal daily range then 2-3 dollars is as far away as the distance needs to be set. This is one of the inputs that depending upon the market you are trading will need to be adjusted.

FLUCOLLAPSEMARGIN- VERY IMPORTANT -- this input will compare two confluence areas and eliminate the weaker of the two that are within X points of each other and keep the stronger of the two. A filter of which areas are the best that are close to each other if you will. The greater this number the less lines you will have on your charts and the more significant those areas will be. The smaller the number the more

lines you will have and the less significant they will be. It is important that you set the software up properly to fit your needs and goals. For example if you are trading forex and trade for 10-20 pips then probably a 30-50 pip collapse would be what you would look for. Experiment with this setting.

LINE WIDTH -- how wide the support and resistance lines will plot. The larger the number the wider the line will be on the chart.

UPDATE PERIOD - how often the program (in minutes) will rerun it's analysis. 1440 is once per day. 720 is twice per day and so on. If you run Daily data .. you will need to make your MAX FLU DISTANCE INPUT much larger .. your Collapse much larger and you will need to set the update period to -7 which is once a week... you can also pick which day of the week you can update them on. See chart below.



Installation process for the T-3 Fibs ProTrader


To install the programs you will have to run the T-3 Setup.exe file that is supplied to you from Nexgen.

If you downloaded the files you will have to run the Setup.exe by double clicking on it. If in Hotcomm you will need to click on the files sent to you in your private chat room.


Once you run the setup program you will be at a Dos Prompt installation window that will ask you for 3 passwords to be typed in one at a time and clicking enter after each to get to the next. Call Nexgen technical support for these passwords. You will be asked to read off the key numbers and letters that are specific to your installation.




Once you have typed in all of your passwords correctly and hit enter the last time you will get the following success message. Just hit enter to end.



You will now have to import your Indicators into Tradestation. To do this please open your power editor (2000i) or your Tradestation 6.x, 7.x or 8.x. From the main screen of either you will click FILE then IMPORT/EXPORT EasyLanguage file.





ASSIGNING A WEIGHTING HIEARCHY TO YOUR CHARTS

One of the most important factors when looking at KEY Fibonacci areas is how much potential does each area have for creating support or resistance and either REVERSING the trend or just simply causing a pause in the current trend.

To answer this question we have to look at what we call a weighting hierarchy. Simply put, the more lines you have in one area the more potential you have of a trend reversal in that area. The more larger and smaller timeframes that all have the same price of support or resistance will create the most significant moves.

Think about this question: How many analysts doing Fibonacci, Elliot wave, proprietary indicator analysis, fundamental analysis, trendline work, Drummond geometry, Wolfe wave work, Gann lines, Fib time projection, pivot support and resistance analysis do you think MERRILL LYNCH, PAYNE WEBBER, PRUDENTIAL, FUJI BANK, EVERY OTHER BANK and MAJOR financial institution have, 10 analysts? Hundreds? Thousands? Now, how many BILLIONS of dollars do they have at their disposal? This is your competition. Let's just say if you want to compete with this type of fire power you had better make sure that you are focusing on the best of the best that your analysis can offer and not only looking at one single chart or as we like to say (a single tree in the forest) or they will run your trading account over and never look back and leave you wondering once again where your money went. Many times all you needed was one chart but this weighting hierarchy can only come from using multiple charts. **Add to that the power of the multiple**

timeframe analysis that the program synthetically does and the array of charts that we use and you now have the power of 100 top Fibonacci analysts on your side and at their best every day!

Now that this work is done for you automatically you can very clearly see the HIGHER weighted areas KEY SIGNIFICANT support and resistance areas.

BREAKOUTS - HOW TO CLEARLY DEFINE THEM

Let's do a lesson that everyone who trades or looks at confluence areas and trendlines should know and respect and answer the age old question, " how do you know if a confluence area is truly broken or a trendline is truly broken and when can we go the other way with our trading" This is what you see happening when a RED LINE TURNS BLUE or a BLUE LINE TURNS red. Simply put the market has broken the key Fib area.

There is one scientific and 100% concrete way to define a breakout and it has served us well.

Use a breakout bar technique that requires the market to determine when an area has broken has always in our opinion to be the best. Here are the rules.

YOU MUST HAVE what we call A **BOB – COB** setup.

BOB = break out bar COB = confirmation of breakout

RULES FOR BOB - A full bar (HIGH & LOW of bar) must be beyond confluence... works on Trendlines too just as effectively.

RULES FOR COB - a close must exceed the high or low of the (break out bar- BOB). Low if going down, high if going up. This is your (COB)

IF these criteria are met then you have a confirmed breakout. Depending on your timeframe it may take a while to happen. THE HIERARCHY rules apply here too... the larger the timeframe the breakout the more powerful it is usually. One-minute breakouts will signify the potential continuation of the short-term trend. MULTIPLE breakouts will signal the most powerful continuation of trend.

Let's look at an example of a BOB - COB and a role reversal sell that is confirmed.

FIRST – When you watch the T-3 Fibs ProTrader you have to keep in mind one thing. The BLUE LINES ARE THE TOP OF THE SUPPORT WINDOW – The RED LINES ARE THE BOTTOM OF THE RESISTANCE WINDOW. Thus creating a "ZONE". For cleaner charts we chose to only plot one line per zone and not a box with the software. Also keep in mind that the software does all of this for you automatically. I just feel it is important for you to be able to have a clear understanding of what the mechanics are behind the color changes of the areas and the implications they have for the overall trend.



Here is a one-minute chart with BLUE LINE as support. As you can see we have labeled the entire support zone for this illustration.

The BOB or breakout bar is the first bar that is ENTIRELY PAST the zone. As you can see labeled in magenta on this chart.



Then you must mark the LOW OF THE BREAKOUT BAR (BOB) as the level that must be closed lower than to confirm the breakout. This is the price that if closed below will signal the highest potential of the continuation of the trend as you can see we marked this price in white.



Once you get a bar that closes below that confirmation point you will have a confirmation of breakout. COB. As you can see we have labeled this in CYAN.



This is incredibly important when trying to determine future direction of the market using larger and smaller timeframes in conjunction with each other. This area that WAS SUPPORT BLUE) has now become RESISTANCE (RED). The key to this type of confirmation is when the market retests this new area of resistance where sells can occur in the direction of the trend.



This technique when used with multiple larger timeframe analysis and smaller timeframe analysis will help to keep you on the "right " side of the trend most of the time.





NEXGEN SOFTWARE - TRADING PLAN FOR NEW CLIENTS TO START WITH

Before you start trading, you must accept the following:

- 1. This is a business you are getting involved in.
- 2. As with any business, you need proper planning before startup, and this includes:
 - a. Long Term Capital Planning.
 - b. Daily business operations.
 - c. Weekly and monthly reporting.

Long Term Capital Planning

FIRST STEP- What will my business cost me to buy into it? Every business you buy or start has costs associated with it. Know your costs to start your business.

- Software Costs
- Data Feeds
- Trading capital
- Commissions

SECOND STEP- what is my potential for making money with this business after costs and startup over the first 12 months? How long will it take me to recover my initial investment into the business if my plans are met?

- Is the risk worth the potential reward?
- Do I know how much money I should make at the end of the first year?
- Do I have adequate capital to even start this business?

Without knowing how much you could potentially make how can you possibly go forward with a business plan? Impossible... so know what you are trying to achieve.

Let's break down some of the simple potential for your new daytrading business.

- 1. Trade only 1 e-mini for every complete \$6,000 in your account.
- 2. Set a target profit for each day if you aim for 3% of capital employed each day. Now this sounds ridiculous, 3%, but look carefully at the numbers. On a \$10,000 account, you can only trade 1 e-mini. For the day, then, aim for \$6,000 X 3% = \$180 net of commissions.
- 3. When broken down even further, on each contract, that is 4 points total for the day on ES and 2 points on.

4. Ok, and finally, a mathematical example of what your business has the potential to make if you can consistently pull out just 3% each trading day on average. Very few realize the enormous impact starting small can have. Using \$6,000 for each mini contract you trade for simple rule and money management on when to add on new contracts.

Let's say you start with \$10,000 account this = 1 e-mini.

Let's also say, that in a typical day, you only make 3.75 points(ES) or 2 points in the ER2 (or 3%) net.

At the end of week 1 you will have: $5 \times 3.75 \times $50 = 10,937.50$.

At the end of week 2 you will have: $5 \times 3.75 \times $50 = 11,875.00$.

At the end of week 3 you will have: $5 \ge 3.75 \ge 50 = 12,812.50$ - great, so now we start trading 2 e-minis.

At the end of week 4 you will have: $5 \times 3.75 \times 2 \times $50 = $14,687.50$.

At the end of week 5 you will have: $5 \times 3.75 \times 2 \times $50 = $16,562.50$.

At the end of week 6 you will have: $5 \ge 3.75 \ge 2 \le 50 = \$18,437.50$ - excellent – now up to 3 e-minis.

At the end of week 7 you will have: $5 \times 3.75 \times 3 \times 50 = $21,250$.

At the end of week 8 you will have: $5 \times 3.75 \times 3 \times 50 = $24,062.50$ - see, now up to 4 eminis.

See how quickly your initial capital outlay is recovered in this model if you achieve the 3% average per day? By the end of week 6 of real trading you have paid for your data feed costs and have fully recovered the upfront (software cost) of your new business and now your business is operating debt free and the ability of your business to generate profits is now up to your allocated operating capital and money management strategies.

IS THIS BUSINESS WORTH THE START UP COSTS AND RISKS? IF yes then get started if not then don't do it ... simple scenario you should play out before you go any further.

SO IF you are moving forward.. Every Monday Morning

- 1. Take the capital in your trading account, and divide by 6000.
- 2. That is the number of contracts you must trade this week. I say must, because very shortly you will see that if you do not follow this method, you will reach the Law of

Diminishing Return, and that is when trading becomes dangerous if you are underfunded in your trading account per contract traded.

So, for a \$10,000 account - 1 e-mini for a \$25,000 account - 4 e-mini's - always round down, not up for a \$75,000 account - 12 e-mini's

Every Trading Day – before market open

- 1. Ask yourself the following questions when you sit down at your screen:
 - a. Did I get a good nights rest last night?
 - b. Am I tired, hung over, feeling sick, angry or depressed?
 - c. If any of the above applies to me, I turn off my machine, and take the day off. Never ever trade (run your business) when you have the above malaises.
- 2. Know exactly how many contracts you can trade, and enter that number in the size box of your broker system.
- 3. Do your pre-market preparation yourself, completely. Don't rely on anyone else, ever – you are the master of your own destiny, and you need to believe in yourself completely. There is nothing wrong with checking your planning with someone else, but you need to take responsibility for your business.
- 4. Plan your day, where you will look to sell, buy, and exit if long or short and when you will stop trading.

Every Trading Day – after market open

- 1. Enter the market at your prices.
- 2. Whatever the entry criteria, the risk can never be more than the % return the plan expects for the day. So, for example, never more than ½ of the daily target of 3%, or 2.25 points, including costs. (this is rough guide but stops not too much bigger than that or too hard to recover from losses.) more on stops later in the plan
- 3. The **<u>potential target</u>** must be at least equal to the initial stop, or will not take the trade. There must be enough room for the trade to move that far, or the odds start stacking up against the intended position.
- 4. You can alter my actual exit at any time, as long as when I entered the trade, rule 3 was valid.

5. Exit methods are preferred to be on limits. <u>Note</u>, if the limit is at or near a major confluence zone, I will always leave 2 ticks room. That is to say, leave enough room for the price to actually get to your area, remembering that to exit on a limit, the price usually has to go 1 tick beyond.

6. Losses

7. If I have 2 losing trades in a row, which would mean that I am now at 3% loss for the day, I will stop trading and re-evaluate.
Is my prep correct? Did I enter correctly? Did I read the market correctly? Etc. Don't beat myself up – losses are part of the game, but that is it for the day

8. <u>Winners</u>

Keep trading your plan, taking all entry rules as you have defined. When your accumulated profit for the day equals your goal of 3%, you decide – carry on, or stop.

Every Trading Day – after trading for the day

- 1. Record all your trades in your log.
- 2. This can be as simple as just writing down the trade taken, why you took it, what you made or lost, and if it was as you had planned.
- 3. Print out your account activity from your electronic broker, as you will be amazed at the errors that appear the next day when your statement arrives by email.
- 4. Backup your Tradestation folder, and defrag your hard drive.
- 5. Leave your desk and enjoy the rest of your day.

Every Month End

- 1. Balance your brokerage account.
- 2. Calculate your monthly profit/loss, and update your accounting system. I use Quicken, and it works like a charm.
- 3. Pay your bills, your rent, and your living expenses.
- 4. Work out roughly your potential tax liability. This should be done on a running monthly basis. So for example, profits this year to date, say 10,000 Then taxes that will be owing = +- 3,200.
- 5. Set this amount aside, in a separate bank account, and leave it there.

- 6. Update this amount each month, either reducing or increasing as needed.
- 7. With the amount remaining after all of 1 thru 6 above, put 80% back into your trading account, and
- 8. You must get into the habit of rewarding yourself for a job well done This is one of the only businesses you will be involved in that you will have where only you can give yourself a bonus!!!!

Every Quarter End

Whatever the balance is in your account from all the prior 3 months potential taxes owing, in 6 above, send off to the IRS, or whatever your tax authority is, as an installment on the current years taxes.

If you do this, you will never have to scramble for tax owing money in April.

Check your balance in your broker account – if it exceeds 50,000, have them put it into 90 day T-bills – they should be margined 100%, and they should not charge you at all to do that – this way you earn interest, instead of the broker.

Every Year End

Ok, it's the end of the year - now the fun stuff.

If your account, after all is said and done is \$180,000 or more, take \$100,000 out and invest it into something else. It does not matter what – real estate, a home, your mortgage, a car, whatever. – Just take it out and start building a retirement, low or no risk portfolio. DO IT. Then recalculate your account and your new trading size.

T-3 FIBS PROTRADER SIMPLE TRADE PLAN RULES

(YOU WILL NEED TO MAKE YOUR OWN WRITTEN PLAN BEFORE YOU TRADEWITH REAL MONEY BUT THIS PLAN WILL GIVE YOU A START ON YOUR OWN BASIC PLAN AND CAN BE USED IMMEDIATELY IN YOUR ASSESSMENT OF THE SOFTWARE AND IT'S POTENTIAL PROFITABILITY)

The goal of this plan is to make at least \$500 per day per two contracts in the ER2- to be used as a starting spot.


- 1. Have enough capital to trade 2 contracts .. \$10,000 -20,000 is a good starting spot for most traders.
- 2. The market to trade is the ER2 because it has sufficient liquidity and movement to reach my goals on a daily basis. You c market but learn it on the ER2 then use the same rules on any market.
- 3. My Max loss per day is 3 points per contract or \$600 dollars. I will never exceed this if a stop is to make me exceed this more today and not take that last trade. (protection from self) and can recover in 1.5 average winning days.
- 4. My Max win per day will be 3 times my daily goal or 7.5 points per contract at which time I will stop trading and go do s

- 5. I will trade with the trend...... as defined by several key factors... MACD BB LINES trend as defined by MACD BB DC lower low crosses on the short term triggers.
- 6. IF your at resistance or support and divergence you will sell or buy a crossing of the shorter term triggers lines and or a p
- 7. If you are at mid bands with trend and have not yet hit your next area, which means you have sufficient room to your ne or resistance areas the you will look to buy or sell off mid bands after close on proper side of shorter term triggers with s or mid bands. This pullback lessens risk and maximizes reward- don't worry about ones that run.
- 8. STOPS just on other side of the HIGH OR LOW that got you in.
- 9. If buying or selling mid bands ... then the first run towards outer bands or first one to ones alternates are your first profit trail your stop.
- 10. IF at upper bands and selling with resistance and divergence-- the mid band is first target then trail stop behind smaller the
- 11. If at lower bands and buying with support and divergence-- the mid bands will be the first profit target then trailing stop
- 12. If I lose a trade at an area I will wait until the next setup and will not continue to try to sell an up market or buy a down n breaks it usually keeps going ... I will look for a continuation off of fib areas and mid bands.

This is two very simple setups that can maximize your demo time and give you clear concise areas to watch while on your demo. grows... so will your trading options.

IF you do average 2.5 points per day net for the 20 trading days in a month that works out to be

\$500 dollars per day

\$2500 per week

\$10,000 per month

Do that for 2-3 months in a row then take your contracts up with profits.

- This may include a spreadsheet to track actual performance on paper or real time trading.
- A diary of sorts that will track your thoughts and feelings for each trading day.
- Learn how to MARK UP (draw on) your charts and take snapshots of the day so you can go back and compare what you see after hours to what you saw live during the day. A great trader will see the market the same IN REAL TIME as he will see the setups historically. When you see in real time what you can see historically you know you will be ready to trade real dollars. This is your FIRST test to understanding your trading plan.

□ yes □ no I HAVE MORE THAN ENOUGH CAPTIAL TO TRADE THE NUMBER OF CONTRACTS I INTEND ON TRADING. VERY IMPORTANT!!! Not having a plan and not having enough money are the number one killers of day trader's dreams! Don't be caught without a plan or without enough money to get through your learning curve so you can reach your full potential and your business plans and objectives. □ yes □ no I HAVE SUCCESSFULLY "PAPER TRADED" my plan for at least 50 trades before trying to trade with any real money. VERY IMPORTANT! No company releases a new product to the market without testing... just because the others who have experience are doing well doesn't mean you will until you have achieved a certain level of efficiency in the execution of your plan.

□ yes □ no IF my real trading deviates from my paper trading results then I will immediately quit trading real money and do an honest and accurate assessment of my entries and exits and my ability to follow my plan. Make any changes that are needed then start the process over --- paper trade for 50 trades then start back to real time trading. While this process seems tedious and time consuming it is imperative that you trade your plan properly so that maximum results can be achieved for the time spent. Trading LOSSES will far outweigh any " time value" loss and will only lead to frustration and the inability to trade successfully.

□ yes □ no I have at least one backup for my data or broker platform if my data goes down and I am in a position. This may include DUAL INTERNET- TWO COMPUTERS minimum – Two trading accounts – Phone numbers to trading desk to exit a position immediately.

□ yes □ no IF I MAKE A MISTAKE ON ENTRY- EXIT IMMEDIATELY REGARDLESS OF LOSS OR GAIN ON THE TRADE. REGROUP and wait for the next setup that meets your trading plan objectives.

□ Yes □ no I KNOW WHERE MY STOP WILL BE WHEN I ENTER

□ Yes □ no I have a key Fibonacci support or resistance confluence that has supported my intended position in the market. This is when you get on your toes and get ready for a potential trade setup to happen.

□ Yes □ no I have Bullish or bearish divergence supporting my counter trend position or Macd BB lines trending and trend supporting my continuation with the trend position.

4 BASICS OF DIVERGENCE – TREND and MACD BB LINES & expected outcomes of each of the setups.

- 1. Higher Prices and Lower Macd BB lines = EXPECTED REVERSAL TO DOWN SIDE - or Bearish Divergence- RESISTANCE SHOULD HOLD.
- 2. HIGHER PRICES & HIGHER MACD BB LINES = TRENDING UP --- no reversal expected RESISTANCE MAY BREAK.
- 3. Lower Prices and Higher Macd BB lines = EXPECTED REVERSAL TO UPSIDE... or Bullish Divergence-SUPPORT SHOULD HOLD

- 4. Lower prices and lower trending down Macd BB lines = TRENDING DOWN -- no reversal expected SUPPORT MAY BREAK
- 5. The higher the timeframe of divergence or non-divergence the larger the expected move.

If dual one to ones then all contracts to be taken off at dual one to ones with close below trigger lines on lower timeframes. This is usually with trend on smallest timeframes and against the trend on the larger timeframes so quick and cautious on these trades.
- 2. If at a key resistance with divergence on smaller timeframes first signal of trend change, which is usually a B pivot short potential or trend down, is to be taken. Since this is first attempt at selling the top the more supporting factors you have for this type of trade the higher your chances of winning which include (outer T-3 Trend Bands, One to Ones from one or more timeframes, Divergence, Fibonacci Support or resistance) First target areas are mid bands and or One to ones then break even on any remaining contracts. If dual one to ones then all contracts to be taken off at dual one to ones with close above trigger lines on lower timeframes. This is usually with trend on smallest timeframes and against the trend on the larger timeframes so quick and cautious on these trades.
- 3. If at a key support with divergence on smaller timeframes AND LARGER TIMFRAMES – first signal of major trend change, which is usually a B pivot long potential or trend up, is to be taken. Since this a first larger timeframe attempt at buying bottom – target areas are mid bands and or One to ones then waiting until you have hit a key Fibonacci area – outer bands- larger timeframe one to ones or Mid bands and have a signal to exit the trade generated by the ABC's or Macd BB lines with divergence.
- 4. If at a key resistance with divergence on smaller timeframes AND LARGER TIMFRAMES – first signal of major trend change, which is usually a B pivot short potential or trend down, is to be taken. Since this a first larger timeframe attempt at selling at top – target areas are mid bands and or One to ones then waiting until you have hit a key Fibonacci area – outer bands- larger timeframe one to ones or Mid bands and have a signal to exit the trade generated by the ABC's or Macd BB lines with divergence

Supplemental thoughts to this rule.

- 1. Since we are now trading with the trend we will not need as many factors as we will need with counter trend trading. However the more factors you have with the trend trades the higher your chances will be for a successful trade. The more timeframes that are in your intended trend position the stronger the potential of the move. If trend is UP and MACD BB LINES are crossed in upward trend then ABC trades with the trend are to be taken. NO COUNTER TREND TRADES HERE.
- 2. Also Mid band pivot continuation trades are to be taken with the trend. Trend trades that are on the "PROPER" side of the mid bands are key to watch for as well. Mid band trade setups can be used on the lowest to the highest timeframes. Watch for ZERO LINE REJECTIONS on the MACD BB LINES at the mid bands on each timeframe for continuation trades with the trend. Targets are to remain the same as all other trades. One to ones outer bands key confluence areas with a signal to exit. Staying with trend trades is important and several factors that can keep you in trades are as follows. Trigger lines spread out wide in direction of trend. Macd BB lines angle of attack in intended direction is steep and crossed in favor. Also lack of divergence for counter trend trades when you reach a confluence area can signal that you have the potential to hold on for more in your trade.
- 3. If you have smaller timeframe divergence AT the same time you are at a potential buying area on the larger timeframes then this will represent a higher percentage win trade as well. For example... your 55-tick chart has a C counter long that has bullish divergence on the Macd bb lines... at the same time you are in a trend UP and Macd bb lines UP on 110-tick chart and at the 110 tick chart mid bands. This will be your signal that continuation trades with the larger term charts should be taken immediately.

Supplemental thoughts to the aggressive trade setups.

- 1. To take aggressive trade setups you MUST do so with the utmost confidence and with as many reasons for doing so as possible. If you focus on doing only aggressive trades you will have a mental perspective of counter trend scalping which is a very tough thing to do.
- 2. You MUST get in to your aggressive trade with as little risk as possible
- 3. You MUST NOT wait for pivot paintbars if you are going to get in at the best spot possible in your trades.
- 4. You MUST have at least 1:1 risk reward ratio and even higher is better to your first target areas.

- 5. To trade aggressively against trend you must have at least 4-6 of the following conditions met.
- Market at outer trend bands on at least one timeframe MORE is better
- ONE to ONES have been hit THIS one is KEY for new traders.
- Key confluence areas have been hit
- Divergence is present on one or more charts... you cannot trade against trend without divergence present!
- Key trendline areas that you have drawn are present and have been hit (trend channels for example)
- Multiple markets are at key confluence areas (for example SP and Russell hit support or resistance at same time or Bonds and Notes at same time)
- Multiple market divergence that happens at the same time.
- Multiple timeframe one to ones are more powerful as well
- Multiple market one to ones at the same time are hit are very powerful
- YOU MUST PLACE ORDER On first close below lower timeframe trigger lines. This will get you in fastest and give you a high or low to place your stop above.
- First target areas for almost all aggressive trades will be the mid bands on the smaller timeframes
- Then you will reduce risk and lock in some profits and see if the market will run.
- If you lose the aggressive trade on an area... Don't try it again and again if the market gives you the conditions again. ONE and DONE will keep you from aggressively counter trend trading your way to ruin in a one way trending market.
- Practice MANY aggressive trades before you actually do any of them
- Food for thought is only do aggressive setups when already up money on the day.
